ADVANCE NOTICE

[VAT] VAT AND DEDUCTIBLE VAT INFORMATION IN EXPORT FILES

SYNOPSIS

The latest format of the export file (from July 2022) has integrated new columns/elements containing VAT and deductible VAT information. This change was introduced to manage the dedicated VAT accounting keys and the multiple VAT amounts introduced for the multi-VAT feature.

The VAT accounting key wll become the unique place to get VAT segments and deductible VAT segments to simplify maintenance. VAT segments and deductible VAT segments will no longer be supported in the accounting alias.

Please note that VAT amounts and deductible VAT amounts are already available in the new columns/elements.

From 24.2 (April 2024), VAT and deductible VAT information will have to be retrieved from the new columns/elements for all clients regardless of the use of single VAT or multi-VAT.

The old columns/elements containing VAT and deductible VAT information will no longer be populated following Neo 24.2 (April 2024).

[RAIL] FULL PAO FOR AMADEUS

SYNOPSIS

Amadeus will migrate to FULL PAO SNCF with the ability to handle multi-inventories booking in a single booking such as TGV + TER. Amadeus will need the PAO reference in the passive segment to support SNCF bookings. This constraint will have an impact on the passive segments. Instead of sending the Resarail reference, Amadeus will be expecting to receive the PAO reference (which is already the case for TER and Eurostar) to make the claim of the SNCF reservation into the PNR to be issued.

This is the planning based on information shared by Amadeus:

- 28 March: "Dual" mode, the claim with both Resarail and PAO Reference will be possible. At the same time GDS will be able to handle multi-inventories reservation. This mode must be requested by the travel agencies to Amadeus.
- 12/13 April: "Go Live". Only PAO reference will be recognized by Amadeus.

If the passive segment does not contain the PAO reference travel Agencies won't be able to do the claim and to issue the reservation. Neo is already FULL PAO and in capacity to manage multi-inventories since several years. However, those changes imply modifications in the Amadeus passive segment sent by Neo and the activation of multi-inventories.

MANDATORY ACTIONS BY TRAVEL AGENCIES:

- Travel Agencies must contact Amadeus, to confirm the dates. It is recommended to start by a Dual Mode and then go Live two or three weeks later. Ensure that the passive segment modification is installed in production during the dual Mode period, the earlier the better.
- Travel Agencies must make a request to Neo for the modification of their Passive segment following the standard process in order to send the PAO reference and no longer the RESARAIL. Please note that this will not be done automatically.

NOTE: This modification must be done through a Service Pack or a Version. If the Amadeus planning does not change it will be required for the 23.1 SP3 - the passive segment must be changed after the Amadeus's activation of the Dual mode and before the "Go Live".

 Optional but strongly recommended: Activation on Admin side of the SNCF multi-inventories in order to make a single booking for TGV + TER.

(NOTE: Due to the "liberté Tarifaire" project all regions have migrated to a different inventory)





[NEO] NEW SUSTAINABILITY API

SYNOPSIS

Sustainability is becoming more and more important, and companies are asked to report CO2 emissions. Neo's objective is to provide the best method for calculating. With more granularity in results, travelers will be able to select more accurate information.

Previously, there were three different methods of calculation displayed for CO2 emissions: ADEME, DEFRA and EPA. These options were managed internally and based on public information from within the organism.

In this version of Neo, the new "Choose Integration" allows Neo to improve the values of these three calculation methods with even more granular data. Three further methods of calculation will be offered: ICAO, IATA RP 1726 and IATA CO2 connect. These methods include aircraft type when choosing transportation in Neo.

NOTE: IATA methods are new methods in the industry and can be activated in Admin suite. Due to the novelty of this integration, it is not possible to exclude that this could be limited and based on commercial discussions with IATA.

Further information is available in documentation made available by Neo.



CONFIGURATION

To determine the amount of CO2 emissions, there is a main method of calculation.

The backup calculation methodology will be used to calculate rail and legacy pages (Multitraveler). This will also be the method used in case the main calculation fails. The back-up calculation is the existing tailored. calculation from Neo.

IMPORTANT: ICAO and IATA methodologies do not offer rail calculation methods.

Administrators can select either DEFRA, ADEME or EPA for rail.

If the main selection is one of the three the administrator won't have the choice to select the same of the last three in the back up rules.

NOTE: Previously Admin Suite offered a check box named "Display CO2" which was mainly used for legacy by default when Neo offers a CO2 display with ADEME. For customers where this check box is not selected, the new frame will present ADEME in both main calculations and the back up calculation.

In admin suite the existing setting frame that contains CO2 will be migrated to a new frame:





[TRANSPORT] SEARCH EARLIER OR AFTER OPTION



SYNOPSIS

Neo continues to make the booking experience easier for users by adding new options. Users will be able to extend searches before or after the selected time, and a search of +3 or -3 hours based on user preferences will be relaunched.

Buttons will only be visible when entering exact time in the search form. Flexible travel time or time range are not part of the scope.

Users will stay on the results page if they do not find the transport solution they were initially expecting. It is expected that by engaging more with users. Navigation would also be made easier if providers respond with a limited number of results.



Please note that this is the first step of a longer project where unpriced solutions will ultimately disappear, and the flexible time feature will no longer be needed as users will have an easy way to move from one time range to another. More is to follow in upcoming versions of Neo.



As a result, Neo now provides users with an explanation of this sorting providing users with an enhanced comprehension of the sorting of results and the display. Users will therefore understand that sorting is based on their company set up which is based on several criteria.

To provide this additional information, contextual information has been added, explaining what recommended transports are based on.


In this version of Neo, there are improvements planned which are aimed to better target customer requirements, improve conversion, and allowing users to spend less time finding the flights or trains that corresponding to their travel needs.

Neo will better query the GDS to always target the time requested in addition of best flights options. This will be done by making queries more specific and restricting them, which will ensure that Neo precisely offers the options which are requested by travelers.


Neo is always attempting to match the best results based on users searches. For example, to find direct flights when possible. In addition to the existing neo algorithm, a neutral GDS query will be launched based on the user search if flight hours are not part of the user request.



When users are unable to modify details of the trip, they need to have access to the travel agency who can then make the modification or exchange on behalf of the traveler.

For times when services cannot be modified or changed online, Neo has made travel agency details known to travelers on a pop-in.

At the end of the message indicating that a modification or exchange is not allowed, all travel agency details will be supplied (including email, phone number, address and opening hours).




SYNOPSIS

Feedback from users have made it aware that too many "Not Available" results appear which are not able to be filtered. The following improvements have been done on the hotel results page in order to improve the user experience during a search for hotels in Neo:

Additional clicks will be reduced by the addition of a new Show more hotels button. By clicking on this button
up to 192 hotels can be displayed on one unique page, allowing users to make a better comparison between
hotels.



- While loading further results, users can now display an already selected hotel without having to wait until the page finished loading.
- Hotels which are "Not available" or "Not allowed" and those which are "Available" will be displayed in two distinct sections.
- When 10 or more hotels are available, hotels which are not available or not allowed will be hidden. However, users will be given a choice if they wish to view these hotels.








SYNOPSIS

To better accommodate disabled users from the very first step of the booking flow, improvements have been integrated which aim to provide users with the possibility to modify bookings easier and more efficiently.




The interface design has also been improved for when a user edits or adds a hotel during a trip search:

Users are now better guided as to what they are allowed to do without being blocked later in the user flow, improvements have been made for date picking.

Date picking for hotel searches is now easier to use by disabling past dates as well as those which are too far into the future. It is also now possible to select the same dates for check-in and check-out for hotel searches:

To avoid confusion and reduce sending out too many emails, Noe will no longer send a cancelation email to users regarding trips canceled outside of Neo with an offline agent or tool.

[EMAILS] EASE PARSING OF NEO TRAVEL EMAILS

SYNOPSIS

Whereas Neo does not recommend email parsing, this can be done by providers and customers parse Neo emails for internal processes.

By standardizing the content in a hidden section, Neo has made the visual HTML and technical tags independent and able to be parsed. This avoids dependency with visual and potential changing versus tags used for different rootings.

[PNR IMPORT] ERROR HANDLING

SYNOPSIS

Only one solution will be able to be used for PNR Import in order to have offline PNR in Neo. All other offline tools will be smoothly decommissioned starting from this year. Neo now flags new PNR import reason of errors to manage re-import if needed for agencies, ensuring that Neo maintains a high level of quality.

Therefore, to help agencies manage rejected PNRs and prevent PNRs from looping when a PNR is rejected, a remark is now added precising the reason for rejection. Please refer to the table below which specifies the error and the reason for the errors.

After five attempts, this specific PNR will be blacklisted (i.e., if it comes back in the import queue, it will be ignored.

The wording of the added remark in the case of blacklisting has been changed, and now reads: "IMPORT REJECT MAX FAILURES PERMANENTLY IGNORED."

There is no way to remove the PNR from the blacklist. A blacklisted PNR cannot be reimported under any circumstance

- emails
- export files generated





SYNOPSIS

To help accountants to identify VAT information to check, a warning is raised in the list view and in the expense line form if VAT amounts are incorrect or need to be checked. Accountants are now warned in 3 cases:

- The total gross amount calculated by Neo (based on the VAT rates and VAT amounts) does not match the reported amount
- The VAT rule at 0% and the VAT amount is other than 0
- In multi-VAT, one of the selected VAT rates is at 0%


SYNOPSIS

When scanning a receipt with multi-VAT, rates for VAT will be automatically selected. Also, VAT amounts will be automatically filled in which will further facilitate the creation of expense lines by users.

Multi-VAT information will be automatically filled in, only if scanned VAT rates match configured VAT rates.

When a receipt is scanned, the scanned VAT amounts will be immediately highlighted in yellow, and a label will be displayed so that users can quickly recognize what has been scanned. The yellow highlight is removed after editing the field or closing the form.

This applies when the OCR setting is enabled in the configuration.





[VAT] DISPLAY OF "100% DEFAULT" AS DEDUCTIBLE VAT RULE



SYNOPSIS

When 100% default deductible VAT is applied, "100% default" will be displayed instead of "None" as deductible VAT rule name in the detailed list view and in the PDF.

This improvement helps to avoid confusion with the cases where no deductible VAT is applied.







[EXPENSE] SCAN RECEIPT FEATURE FOR LIST AND CALENDAR VIEWS

SYNOPSIS

The receipt scanning feature enables users to add expenses in a simpler and more automated way. This functionality captures the receipt content and pre-populates the main expense details.

Deploying this feature corresponds with the goal of Neo which is to make as many users as possible benefit from this feature and provide them with a more intuitive expense creation process.

This functionality is available for both the list and calendar views.

For the list view, a new section has been added in the empty state when the list is empty. This section gives users the option to begin the expense creation process by uploading or dropping their receipt in the list view.

For the monthly and weekly calendar views, users will have access to the multiple choices made available to them in order to create an expense line when clicking on any date within the calendar. These choices include:

- Add an expense line without scanning a receipt
- Scan a receipt
- Add an expense from the expense box when available

[ACCOUNTING] PREVENTION OF PENDING AND EMPTY EXPENSE REPORTS

SYNOPSIS

Following the migration of the accounting page, old empty expense reports were inherited from the previous disagreement process. As these reports have been overfilling the pending lists of many accountants, a mass deletion has been carried out.

To improve further the process and ensure that only relevant empty reports remain in the accounting pending list, a new change has been made in the "Reject lines" process.

From this version of Neo, if a user intends to reject the only or all expense line available in the report, they will be redirected to the rejection of the entire expense report. This will help preventing any empty expense reports.

If the user intends to reject only one or some of the expense lines, then the process remains the same.


SYNOPSIS

This is part of the post-migration of the accountant list. Both accountant features in this note were highly requested by almost all customers. These features improve their experience with the page and enable them to have an intuitive list they can work with quickly and easily and especially in parallel of their internal tools. In this case, quickly see the report ID and copy it to paste it in a spreadsheet or their accounting tool.

This enhancement includes displaying the expense report name and the report ID in the "Expense Report Name" column of the three accounting lists, including: pending, approved and rejected.

From this release, the report ID will be displayed in bold and in first place. This highlights this element allowing quick identification by users.

This change also makes it so the sorting of the "Expense report" column will now be based on the report ID and not on the report name.


SYNOPSIS

A new feature has been added which will improve the user experience for accountants. Users can now copy a specific piece of information in the accounting list in order to paste it elsewhere.

The report ID in the **Expense report name** column and the employee name can be copied simply by hovering with the mouse.

When hovering, an icon appears which can be clicked to copy the data. The user can afterwards paste that same data anywhere else. A tooltip shows confirmation that the data was copied.

This feature is available in the three accounting lists: pending, approved, rejected.


