

SYNOPSIS


The feature **Exchange after departure** was delivered in version Neo 24.1 and allows travelers and arrangers to exchange tickets when a service has been booked online.

To promote this feature to both travelers and arrangers, a new page will now be displayed.

When opening a ticketed trip, travelers will see the following page, where they will find further information on the possibility to make an exchange following a departure. This new page will only be displayed once for each traveler, and will be displayed in the following circumstances:

- The trip contains an air trip, and the page has not yet been displayed for this condition
- The trip contains a rail trip, and the page has not yet been displayed for this condition
- The trip contains both rail and air segments, and the page has not yet been displayed for this condition

Once the page has been displayed for all of the above conditions, it will be dismissed and no longer displayed for the traveler or arranger concerned.





CONFIGURATION


Activation for Exchange after departure is made in Admin Suite under the node: Travel | Policies | Travel

To benefit from the Exchange after departure, this feature must be activated for at least one CRS in Admin Suite.

Policies

Ticking the checkbox **Enable exchange** enables exchange of trips in Neo.

After clicking on Allow PNR Modification and Enable Exchange, this section CRS allowed for exchange after departure will appear.



SCOPE

This modal is displayed only if the Exchange after departure is activated in the Admin Suite, for at least one CRS



SYNOPSIS


A part of Neo's mission is to offer the best user experience possible. Based on feedback received by Neo in relation to the improvements done on the shopping page enabling users to search before and after, users have made it known that they wish to see direct flights even if the times do not match with their initial search criteria.

An update has now been made to Neo queries allowing the search for direct flights when searching for an exact time in the day.

BEFORE




In the search for a flight from Milan to Dubai from 8:00 am, the flights displayed on the shopping page will have one stopover:

SYNOPSIS

Users will now be able to select a seat for WestJet flights, and therefore finalize their booking for this carrier.

This enhances the user experience since prior to this release, users were able to see and select a seat on the seat map for WestJet. However, at the end of the booking flow users received a warning which states: "Your seating request could not be fulfilled."

[RAIL] TRAINLINE: PARTIAL ERROR MESSAGE FOR CANCELATIONS

SYNOPSIS

As part of the creation of the new Trainline API and the RDG accreditation, Neo has improved the message displayed to users when they perform a partial cancelation. For clarity, Neo now displays this message to users if part of a trip has not been canceled.

When travelers cancel a Trainline ticket, and not all legs have successfully been canceled, the message will read:

"The cancelation has been proceeded partially according to the cancelation policy of the fare(s) booked. Please disconnect and then reconnect to see the non-refunded ticket(s)."

SCOPE

This message will be displayed when travelers cancel a Trainline trip, and when at least one of the legs of the trip is not refundable or able to be canceled.
