SYNOPSIS

Neo will be implementing changes to its password policy for clients who connect using their Neo-specific username and password directly on the Neo login page. This ensures alignment with PCI-DSS v4 requirements.

This update will set the password change deadline to a maximum of 90 days (currently set to 365 days).

For clients who have implemented a more restrictive password change rule, this change will not affect them.

To alleviate the fatigue of updating passwords every 90 days and to improve security, it is strongly recommended to use Single Sign-On (SSO) authentication. SSO provides a more streamlined and secure login process, removing the need to manage specific passwords for applications.

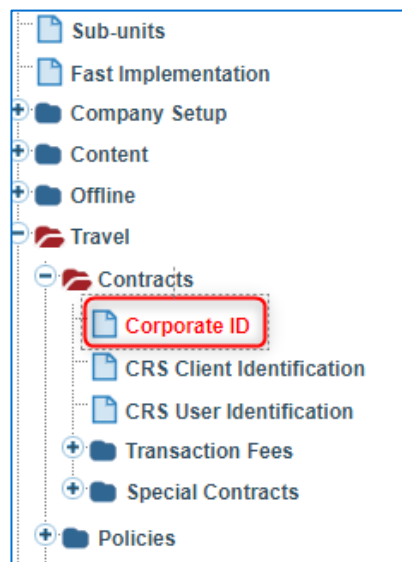

SYNOPSIS

NDC fares can be associated with either a corporate contract or an OIN, therefore it is essential to differentiate between the two to retrieve the complete NDC content.

Below includes details as to how this distinction is configured in Admin Suite:

To retrieve NDC content, ensure the corporate ID type is correctly specified in Admin Suite:

- If the corporate ID is used specifically for NDC content, select **"NDC Only."**
- If the corporate ID is an OIN or CLID, select **"OIN/CLID Only."**

NOTE: Other values should not be used.

New customer guides have been already updated, a one-time patch will automatically apply the right corporate ID to existing customers with NDC content in order to cope with the changes which have been announced.
